OF THE LA SALLE CITY COUNCIL  
December 4, 2017**

**A regular meeting of the La Salle City Council of La Salle, Illinois was held Monday, December 4, 2017 at 7:00 p.m. with Mayor Jeff Grove presiding and with proper notice being duly and continuously posted.**

The meeting was called to order at 7:08 p.m.

Mayor also thanked Jeff Bumgarner and his team for their efforts with the annual Celebration of Lights. He stated that the drive thru display is now over one mile long. The aldermen also recognized Katherine Toraason and Lynda Kasik for the great job they did running Bingo during Miracle on First. Mayor also indicated that the recent Small Business Saturday was very successful with a great turn-out. He added that this weekend, December 9 and 10, will be the Christkindlmarket in the parking lot at Second and Marquette Streets from 11 a.m.-5 p.m. Mayor announced that Jim Carrico was the winner of the \$500 early bird draw of LPAC's 50/50.

Moved by Alderman Schneider and seconded by Alderman Lavieri to accept the recommendation of the Superintendent of Public Works to purchase lighting equipment from Crescent Electric in the amount of \$133,846 for the lights at the Rotary Park Baseball field and begin the bid process for the installation of said lights. Alderman Schneider suggested that the council consider having discussion concerning changing the closing times of bars from 3 a.m. to 2 a.m. on Saturday evenings. He stated that he believes other towns are considering making this same change. Attorney McPhedran stated that the council can discuss the issue tonight, but no final action can be taken. Attorney McPhedran suggested adding it to the next agenda, so the public has an opportunity to weigh in. Mayor Grove stated that in Police Union meetings some time ago, officers requested that

the extra hour was removed. Mayor said by making this change it would show support for our Police Department. Mayor also stated another option is to issue a separate license for extended hours, but an additional fee would be added. Alderman Duncan stated that if it is not in the public's interest to be open for an extra hour, then we should not make money off of it. Mayor stated that his opinion is it should be 2 a.m. across the board. Alderman Lavieri questioned how places like Flying J would be affected by this change and how it ties into video gaming. Alderman Ptak suggested that we should see if Peru would coordinate with us if we make this change. Brief discussion followed about serving underage patrons. Mayor Grove stated that he does not believe we have a large problem with this and with the police walk throughs that have been conducted, not much was produced.

Alderman Bacidore questioned Police Chief Uranich as to how much trouble occurs during that last hour. Chief responded that bad trouble happens in the last hour.

Alderman Ptak stated that if the Police requested this change, we should respond. Attorney McPhedran will review our ordinance to see if this change could be made now, or at renewal time which is May 1. The issue will be added to the next agenda for further consideration and potential action.

Finance Director Duncan stated that the City has a combined tax levy increase of 3.66%. The non-bond side was a 4.9% increase and the bond side had a .2% increase, resulting in the 3.66% combined increase which is under the 5%. The EAV went up over 2 million dollars, so we expect a slight property tax decrease from the prior year. Mayor Grove thanked the council for its fiscal responsibility to our residents. Much of the increases on property taxes are helping with our pension liabilities that we have to make up for from the past. He thanked the staff for working hard to tighten budgets.
