The committee meeting was called to order at 9:00 a.m. by Chairman Bernabei.

6. NEW BUSINESS

- Priority Dispatch System Response Configuration Review/Changes
 - Approval of Protocol 121 – Mental Disorder (Behavior Problems) determinant 121-B-1 Not Violent response change from “Send 1 officer” to “With caller consent transfer to 9-8-8/Without caller consent Send 1 Officer. This request is to fall in line with CESSA Pilot Requirements.
- Priority Dispatch System Policy Review/Changes
 - No changes
 - CESSA Pilot – April 1, IVRD will go-live with CESSA Pilot. This means on certain low-level determinants, TCs will transfer callers, with consent, to Centerstone 9-8-8. Brandon asked the group to ensure that officers do not self-dispatch to mental health calls. Group discussion on this, and a request made by the group to send out an informational document to patrol. Discussion on WTH making a specific UCR a different color, indicating to patrol not to respond to a starburst. Brandon will work on this suggestion. The group had hesitation about telling officers to hold back on starting with calls they see coming. For now, officers will not be told otherwise, and we will address situations as they come up. Brandon reminded the group that these calls are rare.

7. OLD BUSINESS

- Silent Dispatch Policy/Procedure for IVRD and all law enforcement agencies – this issue has no further work being done as we are concentrating on the new CAD system.
- Central Square CAD Project Updates – Projected CAD go-live is mid-October. The CAD build team has been selected. The Business Practice Review (BPR) will be held in May. Team members will receive invites for the days. Once the BPR is complete, agencies will begin building their respective areas. We will be having meetings to develop system forms for each department to provide uniformity across the system. Officer Gatza also asked Brandon to say that Quicket Solutions will be operating as a stand-alone product, separate from CAD at this time. We will explore interface options down the road.
